# LOT 1: PRIMARY INTERNET SERVICE

# **Service Provider Requirements**

- The service provider should have at least Three (3) Cable Landing Stations
  - Service provider must have at least three (2) Cable Landing Stations in the Luzon, Philippines transiting outside the Philippines for diversity and redundancy
  - Service provider must have at least one (1) Cable Landing Stations in the Mindanao, Philippines transiting outside the Philippines for diversity and redundancy

# LOT 2: SECONDARY INTERNET SERVICE

#### **Dedicated Internet Services**

- Dedicated internet access service connection via Fiber Optic Cable Leased Line to be provided by a duly established ISP or a Telecommunications Company
  - o With Committed Information Rate (CIR) bandwidth of 300Mbps
  - With less than 250ms latency
  - With less than 1% packet loss (average over 1000ping) at any given point in time
  - Must provide at least 99.8% guaranteed network reliability/uptime/availability per month, with a monthly downtime cap of 86.4 minutes

Monthly Downtime = Minutes/Month \* (1 – Availability)

= 30 Days/Month \* 24 Hours/Day \* 60 Minutes/Hour \* (1 – 0.998) = 86.4 Minutes

- The service provider should have at least Three (3) Cable Landing Stations
  - Service provider must have at least three (2) Cable Landing Stations in the Luzon, Philippines transiting outside the Philippines for diversity and redundancy

- Dedicated internet access service connection via Fiber Optic Cable Leased Line to be provided by a duly established ISP or a Telecommunications Company
  - With Committed Information Rate (CIR) bandwidth of 300Mbps
  - With less than 250ms latency
  - With less than 1% packet loss (average over 1000ping) at any given point in time
  - Must provide at least 99.7% guaranteed network reliability/uptime/availability per month, with a monthly downtime cap of 86.4 minutes

Monthly Downtime = Minutes/Month \* (1 – Availability) = 30 Days/Month \* 24 Hours/Day \* 60 Minutes/Hour \* (1 – 0.997) = 129.6 Minutes

 The service provider should have at least Two (2) Cable Landing Stations  Service provider must have at least one (1) Cable Landing Stations in the Luzon, Philippines transiting outside the Philippines for diversity and redundancy

 Service provider must have at least one (1) Cable Landing Stations in the Mindanao, Philippines transiting outside the Philippines for diversity and redundancy

This Supplemental Bid Bulletin No. 1 shall form part of the Bid Documents. Any provisions in the Bid Documents inconsistent herewith are hereby amended, modified, and superseded accordingly.
